Special conditions issued to M/s. MEDICARE INCIN. PVT. LTD.

A) Emission:

- (i) From 1 (one) No. HSD oil fired Incinerator. Capacity-200Kgs/hr. Emission of Incinerator is to pass through Primary chamber, Secondary chamber, Heat Recovery Systems, Ventury Scrubber &Packed Bed Alkaline Scrubber.
- (ii) Minimum stack height should be 30 M from G.L.
- (iii) Temperature of Primary chamber to be maintained not less than 850°C 900°C.
- iv) Temperature of Secondary Chamber to be maintained not less than 1050°C -1100°C.
- v) D.G.Set(63 KVA)-One no.(stand by) to be provided with 3.5 chimney above the roof of the generator room with acoustic enclosure and residential silencer.
 - Stacks to have sampling port, platform and ladder as per Emission Regulation Part III of CPCB

B) Effluent:

- From Process Scrubbed water , Autoclave effluent and floor & Reactor washings to be collected in a water settling tank and filtered in sand filter , carbon filter and re-circulated in the scrubber , as much as possible.
- 2. Domestic- to be discharge through septic tank to soakpit within the unit premises.
- C) Solid Waste: Ash and other solid wastes to be dumped in municipal landfill site as proposed.

D) General:

- Noise Control Ambient noise level not to exceed the permissible limit. Every care to be taken for control noise.
- No additional machinery / equipment can be installed without permission from this board.
- 3) The standards/guidelines for control of noise from stationery D.G.sets prescribed under notification of Ministry of Environment & Forest, Govt. of India dated 22.12.1998 viz. Environment(Protection)(Second Amendment) Rules 1998 to be followed.
- 4) All soild wastes other than those to be incinerated must be disinfected/autoclaved and shredded before disposal.
- 5) Good house-keeping to be maintained.
- 6) Tree planting along the periphery of the unit premises.
- 7) This NOC is valid upto 31.05.2004 for setting up the common Bio-Medical waste Management facility.
