Additional Conditions:

- 1. The unit shall stop its operation immediately in the event of failure of APC measures.
- 2.The unit shall comply with Biomedical waste (Management) Rules, 2016 and the directions issued by the TNPCB
- 3. The unit shall not use 'use and throw plastics' such as plastic sheets used for food wrapping, spreading on dining table etc., plastic plates, plastic coated tea cups, plastic tumbler, water pouches and packets, plastic straw, plastic carry bags and plastic flags irrespective of thickness, within the industry premises. Instead unit shall encourage use of eco friendly alternative such as banana leaf, arecanut palm plate, stainless steel, glass, porcelain plates/cups, cloth bag, jute bag etc.
- 4.In case of revision of consent fee by the Government, the unit shall remit the difference in amount within one month from the date of notification. Failing to remit the consent fee this consent order will be withdrawn without any notice and further action will be initiated against the unit as per Law.
- 5. The unit shall continue to develop Greenbelt of adequate with in premises.
- 6.The unit shall maintain and record the online monitoring data and furnish the same to O/o DEE, Virudhunagar on daily basis
